Terms and conditions

- 1. Application
- 1.1 The conditions apply to a contract between 365 Office, 13Jul Br 3 81000 Podgorica, Montenegro (the seller) and the customer regarding purchase of the item (the product) on offer.
- 2. Signing of contract
- 2.1 This is an offer to enter an agreement regarding purchase of a specied item.
- 2.2 The contract is to be regarded as completed when the customer has paid in accordance with the offer. The customer then accepts the terms and conditions. The order is binding. Due date on the preceding page refers to the date up until which 365 Office can guarantee delivery of the ordered item within the time limit given below.
- 2.3 These general conditions apply solely to purchases of products from 365 Office unless otherwise agreed upon in writing.
- 3. Delivery and delivery time
- 3.1 The seller is obliged to deliver the item within reasonable time, though at the latest within 30 days from the time of the signing of the contract, unless otherwise agreed upon.
- 3.2 In case of delayed delivery the seller is obliged to notify the buyer within the promised delivery time.
- 3.3 The seller bears no responsibility for any damages that may occur as a result of delayed delivery.
- 4. Price and conditions of payment 4.1 The price is given in the current price list at the seller's website, www.365officedocs.com.
- 5. Inspection of the product, and actions to be taken in the event of defects
- 5.1 As soon as the product is delivered, the buyer should inspect it.
- 5.2 If the customer has led claims according to §6, the customer is entitled to rectication of errors. The seller should without fail furnish a new product and at his/her own expense carry out a new delivery, provided this can be done within reasonable time and without inconvenience to the customer. If such rectication cannot occur, the customer is entitled to a reasonable price deduction or to damages.
- 6. Claims
- 6.1 In case of faulty delivery the customer should notify the seller and le claims within the time limits given in §6.2.
- 6.2 If the customer receives damaged or otherwise defective goods, this should immediately be reported, at the latest within 7 days after the goods have been received, provided it is reasonable that the customer ought to have discovered the damage at once. Other complaints should be led without reasonable delay once the buyer has discovered, or ought to have discovered, the defect, though in no case later than 15 days after receipt of the goods.
- 6.3 If the defect occurred during shipping, claims should be led to the delivery company.
- 6.4 If claims have not been led within the the prescribed time, the goods are to be regarded as approved by the customer.
- 7. Return Policy 30 Day MoneyBack Guarantee 365 Office guarantee full refund within 30 days. If the buyer wish to cancel a purchase the seller will accept the return within 30 days of purchase and guarantee a full refund. To be eligible for a refund the product must be intact. I.e. it has to be returned in original condition and that it has not been used. The return should include the original packaging and brand labels. The seller will accept all reasonable returns.
- 8. Hiring of subcontractors
- 8.1 The seller is entitled to hire subcontractors in order to full his/her part of the contract.
- 9. Force Maieure
- 9.1 The seller will not recompense damage due to strike, re, or other circumstances beyond his/her control, and which the seller could not reasonably have been expected to foresee, and the consequences of which the seller would not reasonably have been able to avoid or overcome.
